#### Fund Objective

# Market Review

Taiping Greater China New Momentum Equity Fund is a SFC authorized fund#, primarily focusing on our investment niche of the Greater China region, comprising PRC, Hong Kong and Macau markets. The Fund seeks to provide investors with medium to long term capital appreciation.

Effective from 30 April 2016, the jurisdiction of the Fund (place of domicile) has been changed from Cayman Islands to Hong Kong.

Effective from 30 June 2016, the Fund may invest less than 30% of its non-cash assets in listed equity securities of companies which may have no connection with the Greater China region. Such equity securities are listed on exchanges worldwide including but not limited to the United States. The Fund may also invest up to 20% of its non-cash assets in A Shares via the Stock Connect.

Effective from 31 March 2022, the fund has been revised to provide flexibility to the Sub-Fund to invest directly in
eligible China A-Shares via Shearzhen-Hong Kong Stock Connect in addition to investment via the Shanghai-Hong Kong
Stock Connect. The Sub-Fund's exposure in China A-Shares will be encreased from 20% of non-cash assets to 50% of its
NAV. The Sub-Fund's investment scope in China A-Shares will be exponded to both Shanghai-Hong Kong

The fund's NAV decreased by 14.65% in Jan. Capital continued to flow out, and market sentiment has further deteriorated. Although the recently released PMI data for January has improved, it is still lower than market expectations. Simultaneously, Part of the listed companies released performance forecasts, but due to macroeconomic influences, a high proportion of results fell short of expectations. In Hong Kong dollars, Hang Seng Index and CSI 300 decreased by 9.16% and 7.09% correspondingly in the month. As to sectors in Hang Seng Index, most of the sectors got negative return while Energy sector performed best with positive return.

### Market Outlook

Core CPI remained at 0.6% in December, unchanged from the previous month. Non-commodity PPI has retreated for the third consecutive month, and the market is concerned that deflation may last for a long time. Looking forward, the valuation of the Hang Seng Index is already extremely cheap relative to history and other markets, and there is no need to be further pessimistic. The central bank has announced a 0.5% cut in the reserve requirement ratio to provide the market with one trillion yuan of long-term liquidity, but the market still needs time to regain confidence. With the arrival of the interest rate cut cycle and the subsequent implementation of economic support policies, we expect Chinese stocks to gradually stabilize. We will further adjust the balance of the portfolio structure, increase the allocation of defensive high-dividend blue chips, and focus on growth stocks in the consumer and technology sectors with stable fundamentals and attractive valuations
